The main idea of the paragraph is usually found at the beginning. Supporting details are reasons, examples, facts, steps, or other kinds of evidence that explain the main idea. They include: Major details explain and develop the main idea. Minor details help make the major details clear.



- d) **Finally**, keeping pennies in circulation costs the nation as a whole.





## 1. What is a summary?

A summary is a shortened version of a piece of writing

- in which you include only its **main ideas** —i.e. you leave out supporting details, examples, quotations, etc.—, you write down the main idea of each section in one well-developed sentence. Make sure that what you include in your sentences are key points, not minor details
- which is written mainly using your own words, and which shows you have understood the text.
- There are 4 common elements to include when writing a summary:
  - ✓ <u>Introductory sentence</u>: It states the author and the text's title.
  - ✓ <u>Main points of the original text</u>: This restates the main points the author conveyed using your own words.
  - ✓ <u>Supporting arguments</u>: Here, you list the arguments that support the author's theses or main idea
  - ✓ **Final point**: Restate the author's conclusion or last main point to end your summary.



### 1. How long should a summary be?

Although there is no fixed rule for this, it is commonly agreed that a summary should be **about one-fourth**  $\frac{1}{4}$  **the length of the original**. **e.g**: If the text is **260 words**  $\rightarrow$  summary is **65words**.

- 2. How do I write a good summary?
- a) Read and understand the text carefully.
- **b) Think about the purpose** of the text:
  - ✓ What is the author's purpose in writing the text?
- ✓ What is your purpose in writing your summary? (Are you summarizing to support your points? Are you summarizing so you can criticize the work before you introduce your main points?)
- c) **Select** the **relevant information** —this will depend on your purpose for writing a summary.
- d) Find the main ideas:
  - ✓ Main ideas may be found in topic sentences.
  - ✓ Distinguish between main ideas and supplementary information.
  - ✓ Delete information that is not relevant for your summary —e.g. details, examples, illustrations, data etc
  - ✓ Find alternative words/synonyms for these words/phrases do not <u>change specialised vocabulary</u> and common words.

- e) Change the structure of the text:
  - ✓ Identify the meaning relationships between ideas and express them in different ways.
  - ✓ Change the grammar of the text (rearrange words and sentences. Change nouns to verbs, adjectives to adverbs, etc., break up long sentences, combine short sentences.).
  - ✓ Simplify the text, reducing complex sentences to simple sentences, simple sentences to phrases, phrases to single words.
- f) Rewrite the main ideas in **complete sentences**, combining your notes **into** a **piece of continuous writing**—do not forget to use conjunctions and adverbs such as 'therefore', 'however', 'although', 'since', to show the connections between the ideas.
- g) Check your work.
  - ✓ Is the purpose of your summary clear?
  - ✓ Is the meaning of your summary the same as that of the original?
  - ✓ Is the style of your summary your own style?

#### Water Pollution

In order to have good <u>health</u>, people must use <u>clean</u> and safe water. Safe drinking water is water which is free from all <u>impurities</u> that cause pollution. Water pollution causes <u>diseases</u> such as typhoid, dysentery, cholera, diarrhoea and many others. It also kills fish and other animals.

Water pollution is mainly caused by people's bad use of their water resources. In some countries people throw human and industrial waste into rivers and lakes. In others they throw chemicals and pesticides into streams. Water which contains these <u>substances</u> is dangerous for all people, animals and plants, because these substances are not natural.

Water can also get polluted from within the water supply system. For example, all over the Sudan people keep their drinking water in a water pot called "zeer". It has been found that if the zeer is not <u>cleaned</u> and <u>covered</u>, the water becomes polluted and causes diseases. Also, if people use dirty containers to remove water from the zeer, the water becomes equally polluted. Some people try to avoid this problem by fixing little taps at the bottom of the zeer. In this way, the person can get water from the zeer without putting his hand inside it, so the water stays clean.

#### **Summary2:**

According to a Voice of America article, a fast-growing MOOCs movement allows thousands to take online classes at once, changing how we learn. [it's the appropriate summary because it keeps the original main idea and it is much shorter than the original passage]
